

NURSE AIDE TRAINING 2017

HVA trained 87 students in 2017 - 11 were WIA-sponsored students, 23 were private pay, 46 were facility sponsored, and seven came from other funding sources. Sixty of those students were trained in Erie County.

2017 NNAAP results for HVA graduates are continually higher than all graduates statewide. The pass rate for the third quarter of 2017 was 100 percent for HVA grads in skills and theory. HVA has agreed to be a remote test site (RTS) location for the NNAAP exam beginning January 2018. This will provide our students, other local nurse aide students, and nursing students who have been approved by the Department of Education the opportunity to test in northwest Pennsylvania.



STRENGTH IN PARTNERSHIP

Symbria Rehab HVA, your therapy and wellness partner, closed 2017 with very strong results. These results not only continued to demonstrate solid patient outcomes, but also saw an increase in the Overall Experience rating. We maintained high client satisfaction scores with 82 percent of our client communities remaining very satisfied and would recommend us to others. Our employees rated us a very strong 7.4 out of 10 on Overall Satisfaction.

Symbria established a new Clinical Rehab Operations Department. This team is headed by Vice President Linda Kolleng and is made up of Mary McVay, Bob Przybylak, and Kristin Candiotti.

Planning ahead

We are in the midst of launching a data analysis initiative for our client communities who are interested in participating. The goal of this initiative is to determine the potential impact of RCS-1 as it is currently defined.

Symbria is also taking a different perspective to offer services by looking at bundling various offerings, e.g., rehab with wellness, pharmacy with rehab, wellness with our Service Match assessment tool, and more.

HVA SHARE CARE HOMES

This past July, HVA opened its first Share Care home. Share Care homes are residential, threebedroom homes that house three individuals who share the care in the home. Each resident pays for eight hours of care, either with Medicaid waiver dollars or through private pay. The first home is beautifully decorated and located near Mercyhurst University. A second home was purchased and is currently under renovation. Each individual has a private bedroom and shares the other areas of the home. The program is designed to provide safety, support, and room and board. HVA currently partners with Brevillier Village, who provides the excellent staff that works at the home 24 hours a day, seven days a week. SENIOR NAVIGATOR

2017 was another exciting year for the senior navigator position. It has become a known and established service in the community, generating referrals from all local health care providers. As this role grows, I'm able to reach and help more seniors in northwest Pennsylvania. With a target of 600 families a year, this service helps the community on so many different levels. The families feel comfortable that they have made the right decision because they have been educated on all the options. Hospital readmissions dramatically decrease because families and seniors are connected with the right resource. Equipping and educating families on senior services is the key to success for any senior and their family. As HVA and its members lead the way in senior health care services, I look forward to another prominent year for the senior navigation postion.

2017 PURCHASING RECAP

In 2017, HVA members were experiencing challenges with contracts related to pricing and products. After discussions within our purchasing committee, it was decided to form a subcommittee to explore other GPOs and opportunities for our members. After surveying all the options available, it was decided that we would provide a course of action to our current partner with a timeline to resolve and work toward future goals that were set by our members. We are hopeful that the future of this partnership will provide solutions by reducing costs and providing innovative products and services.

2017 ACCOMPLISHMENTS

- Senior Navigator had over 600 referrals in 2017!
- Renegotiated all insurance contracts for Share Care and HVA Corporate including workers' compensation, D&O insurance, and general liability.
- **Share Care** opened its first location in June; a second location is being renovated with plans to open in 2018.
- **Graduated 87 nurse aides** from our school, which has one of the highest pass rates in the the state.
- Educational offerings included dementia training and certification, and an annual law seminar.
- **Quarterly meetings** with UPMC and Allegheny Health Network resulted in broader partnerships in several areas.
- Marketing with Tungsten to maintain an HVA presence within northwest Pennsylvania. Highlighted the Senior Navigator and promoted HVA as the premier place to work. Statistics look great!
- Coordinated the **HVA Innovation Committee** regarding its four focus areas hospital partnering, mobile dental, central physician practice, and palliative care.
- Managed Care Contracting with Covenant Health Care in obtaining managed care contracts throughout the state. An OPTUM contract is in place at a number of our HVA facilities and negotiations continue with other insurance contracts.
- Symbria Rehab HVA Obtained a contract with Great Lakes Home Health so that our therapists can work with residents on HVA campuses.
- **Grant Writing** Obtained \$10,000 for dementia training and certification and \$8,000 for mobile dental equipment.
- HVA Mobile Dental Sent letters to all dentists in Erie, Crawford, and Mercer counties inviting them to join our program. Meeting set with LECOM to ascertain involvement with new dental grads.
- Market gain of \$219,691.66 on **HVA investments** on monies made from HVA initiatives.
