* Registration Requirements

- Minimum Age: 17 (with parent's signature)
- Watch the video "Nurse Aide: What's it All About?"
- Entrance Test with a score of at least 80%
- · Read, write and speak English
- Submit an a PA CHRI obtained through the Pennsylvania State Police during the year prior enrollment required by Act 14.
- Non residents of Pennsylvania for the last two (2) consecutive years and/or candidates who were convicted of a Federal or out-of-State offense similar in nature to those crimes listed under paragraphs (1) and (2) of the Prohibitive Offenses Contained in 63 P.S. § 675 must submit a PA CHRI and an FBI report prior to enrollment. (1) an offense designated as a felony under the act known as "The Controlled Substance, Drug, Device and Cosmetic Act",(2) an offense under one or more of the following provisions of Title 18.
- A physical exam dated within one year of the start of the nurse aide training program.
- Evidence of a negative 2-step Mantoux. If the Mantoux is positive, a negative chest x-ray that is less than five years old is required.

PLEASE NOTE: While a CHRI is acceptable for nurse aide training, nursing homes could maintain a more stringent list of prohibitive offenses. In addition, you should be aware that Pennsylvania maintains a data base by HHS OIG that identifies individuals or entities that have been excluded nationwide from participation in any federal health care program. Health care facilities are required to develop policies and procedures for screening of all employees to determine if they have been excluded from participation in federal health care programs. If you are on this exclusion list, it is possible that you will not be eligible for employment in a health care agency.
